Our instructors and staff will...

- Do a temperature check before entering the studio, and ensure that it **is below 100°F**.
- Clean/Disinfect frequently touched surfaces thoroughly and at regular intervals.
- Wash/Sanitize our hands before and after each session.
- Wear our masks at all times.
- Maintain a safe distance at all times.
- Accommodate a limited number of students in each class to ensure physical distancing.
- Schedule classes so as to allow time for cleaning/disinfecting surfaces and allow students to finish and leave the studio before the next set of students arrive. **All classes will end 15 minutes early for this.**
- Provide sanitizers in the reception area and other locations within the premises.

We are requesting that each of our students, please...

- Allow us to **check their temperature** before entering the premises to ensure it is below **100.°F.**
- Wear a face mask at all times within the building and within the studio.**
- Maintain a safe distance from others at all times.
- Use the hand sanitizer before entering and while exiting the studio.
- Carry their own bottle or cup for drinking water.
